BOARD ROOM, 39–41 YORK STREET, SYDNEY, ON 15TH SEPTEMBER 1983, FOR THE PURPOSE OF FORMING, WITHIN THE AUSTRALIAN ROAD TRANSPORT FEDERATION, A NATIONAL TANKER TRANSPORT ASSOCIATION", later to be known as the National Bulk Tanker Association.

It is rare that an organisation retains a record of the exact moment it came into existence. The NBTA would like to thank Ian Wright who was present at this meeting, for retaining a copy of the meeting minutes (below) and passing this important artefact for the association on to NBTA Life Member Rob Perkins.

Mr. Rochfort took the Chair and declared the Meeting open at 4.00 p.m.

I. WRIGHT

Mr. Butcher introduced the discussion, outlining the background to the proposed formation of this body.

The Chairman sought the views of both the State representatives and also the representatives of the member companies present, and there was general acceptance of the need to establish an appropriate Association and for that Association to work within the auspices of the A.R.T.F. however, concern that membership might be too limited to justify the establishment of an individual Association.

It was further determined that the best approach to the question would be to form a Sub-Committee, who would meet and consider the issues as soon as possible, with a view that this meeting be reconvened to frame an appropriate recommendation and directive.

It was determined that the Sub-Committee would comprise:

Mr. G. Taylor, representing A.R.T.F. and Convenor Mr. D. Hoffman, as a representative of the States Mr. T. Lording, Mr. I. Wright, representing operators with Mr. S. Collins to nominate a further representative from United Transport Holdings

It was determined that each State Association would advise Mr. Hoffman of their attitude as regards the formation of the Association within one month, and that the operators would liase through Mr. G. Taylor within one month, who would then call a meeting of the working party.

It was determined that the working party examine those matters on the Agenda, numbered 1 to 4. As regards Agenda Item No. 5, attributing to other representative bodies, members were requested to determine their position in the light of proposals for this Association. Agenda Item Nos. 6, 7 and 8 be adjourned to the next meeting.

A motion to this effect was moved by Mr. Beamish, seconded Mr. Taylor.

There being no further business the meeting closed at 5.00 p.m.

EPA NSW seeking advice from industry experts



In recent compliance operations, EPA NSW has identified a number of transfer hoses for class 3 liquids that were worn or damaged to a point where they were no longer safe for bulk transfer of flammable liquids. EPA NSW officers also identified a number of hoses whose condition was suspect.

Part 10.1.3.1 for the ADG Code requires that all transfer hoses undergo a visual inspection for damage monthly: "A hose assembly must be inspected for damage over its entire length at intervals of not more than a month."

To make it easier for tank vehicle operators to have confidence in a decision as to whether a hose would fail a visual inspection, the EPA proposes to provide guidance in the form of some examples of hoses that would pass and some that would fail. In order to develop the hose inspection guidance, the EPA is seeking advice from industry experts as to when a transfer hose is damaged or worn, to a point at which there is an unacceptable risk that:

- 1. Product could leak or weep from the hose during transfer; or
- 2. The hose could disconnect during transfer

The ADG Code 7.8 replaces edition 7.7



The Australian Dangerous Goods Code

- The Australian Code for the Transport of Dangerous Goods (ADG Code) sets out many obligations & duties for all parties involved in the transport of Dangerous Goods.
- This module will provide you with an understanding of key elements of the ADG Code including information contained in the DG list - but due to the complexity of the code please refer to the code for further information.

The ADG Code 7.8 replaces edition 7.7 and comes into effect in Victoria on **Sunday 1 October 2023**.

Duty holders may choose to comply with either edition 7.7 or 7.8 for a period of six months from this date. All duty holders must then comply with ADG Code 7.8 on and from 1 April 2024.

A copy of ADG Code 7.8 is now available on the <u>NTC website</u>. A summary of changes incorporated into the new edition is also attached.

Subsequent amendments to Dangerous Goods Regulations

The DG TRR Regulations give effect to the ADG Code in Victoria. These regulations and the DG SH Regulations have been amended to align with ADG Code 7.8 and the MSI.

These amendments commence on **Sunday 1 October 2023**, and include:

- aligning Victorian dangerous goods transport laws with the MSI and edition 7.8 of the ADG Code
- referencing new chapters of the ADG Code to incorporate references to new United Nations Model Regulations (UNMR) provisions on fibreglass reinforced plastic tanks
- allowing prime contractors to retain and produce documents in relation to the transport of dangerous goods in electronic form as an alternative to the current required hard copy
- a technical change to replace the definition of dangerous goods in regulation 5 and regulation 38 of the DG TRR Regulations with new regulation 22A, which relates to when the DG TRR Regulations apply
- a consequential amendment to the DG SH Regulations to refer to new regulation 22A when determining whether goods are dangerous goods.

Please note, new regulation 22A in the DG TRR Regulations does not introduce any new requirements for duty holders. The application of this new regulation is the same as the existing application of regulation 38 in the DG TRR Regulations.
